Delphi Police Department Report for February 2024

Mayor Yates, Members of the Board of Works and Common Council

Officer Redmon received a complaint of battery and rape. Sgt Deckard, Sgt Parkinson, Officer Reef, and Chief LaMar all responded on their day off to assist. Their response was expedited due to the recently implemented take home care program. Uninvolved third parties, including a juvenile, were safely removed from the scene and the suspect was taken in to custody.

Chief LaMar worked with Jess Banes at DCHS to arrange Troy Cudworth to speak to students about addiction, serving jail time, and making better life decisions without drugs and alcohol. Troy's talk went extremely well. There were so many questions from students that he was unable to answer them all in his given time block.

Chief LaMar and Troy Cudworth appeared on Fox59 to talk about the friendship and partnership has formed. Chief LaMar has arrested Troy several times. Troy wrote one of many letters of recommendation for Chief LaMar for his current position.

Sgt Parkinson's was officially pinned as DPD's newest Sergeant. He commands the night shift.

Jensyn Reef was sworn in as DPD's newest Officer. He is assigned to night shift.

DPD Officers participated in a training at the gun range. This was a night shoot, requiring Officers to shoot in the dark with the presence of red/blue flashing lights

Officer Reef, Officer Kent, and Chief LaMar attended the President's day program at DCES.

Chief LaMar attended the Legislative Luncheon with the Mayor, Clerk-Treasurer, and Councilman Myers.

Officers are still being offered overtime to work school zone traffic enforcement.



Ordinance No. 2024-3

AN ORDINANCE AMENDING ORDINANCE 2023-12 ESTABLISHING WAGES OF CERTAIN EMPLOYEES OF THE CITY OF DELPHI, INDIANA FOR CALENDAR YEAR 2024

WHEREAS, Ordinance 2023-12 was passed by the Common Council of the City of Delphi and approved by the Mayor on the 16th day of October 2023 and set the wages of certain employees of the City of Delphi, Indiana for the 2024 calendar year; and

WHEREAS, the Common Council finds it desirable to create liaison specialties within the City of Delphi Police Department to provide specialized law enforcement leadership and support for local schools, community events, community sports, and parks and trails; and

WHEREAS, the Common Council finds it desirable to compensate City of Delphi police officers assigned as a liaison for undertaking additional duties and serving in a leadership role within their assigned area.

WHEREFORE, IT IS HEREBY ORDAINED THAT Ordinance 2023-12 is amended to include the following statement:

Special Duty Pay

Police officers will receive special duty pay up to \$500 on an annualized basis for the following specialty positions: School Liaison, Events Liaison, Sports Liaison, and Parks and Trails Liaison. Special duty pay will commence upon an officer beginning such position and will end when the officer ceases the position as determined by the Police Chief.

ORDINANCE NO. 2024-5

AN ORDINANCE AMENDING TITLE VII, CHAPTER 77 OF THE CITY OF DELPHI CODE OF ORDINANCES ENTITLED "UTILITY TERRAIN VEHICLES AND GOLF CARTS" AND AUTHORIZING AN EXEMPTION FOR THE USE OF UTILITY TERRAIN VEHICLES AND GOLF CARTS BY THE DELPHI POLICE DEPARTMENT

WHEREAS, pursuant to provisions IC 9-21-1-3(a)(14), the City of Delphi, Indiana, with respect to private roads and highways under the City's jurisdiction, and in accordance with IC 9-21-1-2 and within the reasonable exercise of police power, may regulate golf cars and recreational off-road vehicles, such as utility terrain vehicles (UTVs); and

WHEREAS, pursuant to the provisions of IC 9-21-1-3.3(a), the City of Delphi may adopt an ordinance with additional traffic regulations concerning the use of golf carts and recreational off-road vehicles on streets and alleys under the jurisdiction of the City as long as the ordinance does not conflict with or duplicate state law; and

WHEREAS, Ordinance 2024-4, "An Ordinance Repealing and Reenacting Title VII, Chapter 77 of the City of Delphi Code of Ordinances Entitled "Utility Terrain Vehicles and Golf Carts," was adopted by the City of Delphi on February 5, 2024, thereby permanently enacting regulations for the use of UTVs and golf carts on streets and alleys within the corporate limits of the City of Delphi; and

WHEREAS, the Common Council of the City of Delphi recognizes that the Delphi Police Department has purchased a golf cart to be used by police officers to extend the Department's capabilities to patrol the corporate limits of the City for the benefit of public safety and wellbeing; and

WHEREAS, the Common Council of the City of Delphi desires to amend Chapter 77 of the City of Delphi Code of Ordinances to provide an exemption for the use of golf carts and UTVs by Delphi Police Department police officers to support the Department's efforts to increase patrol capabilities and effectiveness.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Delphi, Indiana, that:

Section 1: The Delphi Police Department is authorized to be exempt from provisions regarding application and fee requirements as well as provisions regulating the permitted locations and times for operating a UTV or golf cart.

Section 2: City of Delphi Code of Ordinances Chapter 77, entitled "Utility Terrain Vehicles and Golf Carts", § 77.20, shall be amended to include an exemption for the use of golf carts and UTVs by the Delphi Police Department police officers within the corporate limits of the City.

Section 3: The amended § 77.20 shall read as follows per the attached Exhibit A.

Section 4: If any section, sentence, or provision of this ordinance or the application thereof to any person or circumstance shall be declared invalid, such invalidity shall not affect any of the other parts of this ordinance which can be given effect without the invalid part, and to this end the provisions of this ordinance are declared to be severable.

Section 5: This ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

EXHIBIT A

§ 77.20 EXEMPTION.

On Armory Road, within the City of Delphi, Golf Carts and UTVs may be utilized by the Delphi Community School Corporation without the need of a completed and approved application or accompanying fee. Should the Delphi Community School Corporation utilize their UTVs or Golf Carts on any other street or road within the corporate limits of the City of Delphi, an approved application and paid access fee are required.

Within the corporate limits of the City of Delphi, Golf Carts and UTVs may be utilized by the Delphi Police Department without the need of a completed and approved application and accompanying fee or payment of annual operator access fees. The Delphi Police Department is exempt from the provisions of § 77.10 regulating the permitted locations and times Golf Carts and UTVs may be operated in order to effectively conduct patrols and respond to calls.

ORDINANCE NO. 2024-6

AN ORDINANCE ESTABLISHING FUND 4650 FOR THE PURPOSE OF FUNDING CONSTRUCTION OF THE NEW WATER AND STREET DEPARTMENT BUILDING

WHEREAS, the City of Delphi, Indiana desires to construct a new municipal building to house the Delphi Water Works and Street Departments; and

WHEREAS, the Common Council of the City of Delphi, Indiana desires to establish a fund to pay for the costs of constructing a new Water Works and Street Department building.

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Delphi, Indiana that:

Section 1. Fund Established. There is hereby established a fund to be known as "Fund 4650" for the purpose of accumulating funds to be applied toward the construction of a new Water Works and Street Department building.

Section 2. Sources of Funding. The contributions to the Fund will be from debt financing and the Delphi Street Department budget, contributions from the Delphi Water Works Department, and any other appropriate fund as approved by the Board of Works and Common Council.

Section 3. Use of Funding. The City of Delphi shall only appropriate and use the funds to cover the costs of construction of a new Water Works and Street Department building.

Section 4. Termination and Balance Remaining. This Fund shall remain in existence until such time as the Common Council repeals the ordinance establishing said Fund. The disposition of any balance remaining in the Fund at the time of termination shall be determined by the Common Council and provided by State law.

Section 5. Perpetual Fund. The fund balance shall be perpetual until terminated by the terms of the current ordinance or by enactment of a subsequent ordinance.

Section 6. Effective Date. This ordinance shall be in full force and effect from and after its passage.

RESOLUTION 2024-6

A resolution of the Common Council of the City of Delphi, Indiana Regarding its declaration of official intent to reimburse expenditures

WHEREAS, the Common Council of the City of Delphi, Indiana ("Issuer") intends to construct a maintenance building ("Project"); and

WHEREAS, the Issuer expects that it may issue debt for the Project and intends to use the proceeds to reimburse or pay costs of the Project;

NOW, THEREFORE, be it resolved by the Common Council of the City of Delphi, Carroll County, Indiana that:

SECTION 1. Issuer hereby declares its official intent to construct the Project and to reimburse itself for the costs of construction and other related costs for the Project with the proceeds of either temporary debt or long-term debt to be incurred by the Issuer, and to issue debt for the purposes of paying and/or reimbursing costs of the Project.

SECTION 2. This resolution shall be in full force and effect upon its passage.
