## **DEPARTMENT HEAD REPORTS:**

STREET: Upkeep on the fleet is being handled. Several trees have been removed. So far there have been 6 this year.

Water: Craig Myers reported the painters are finishing up and the electricians are coming in this week. Well #7 is pumping into the system. Some work is starting on Phase II and within a couple weeks cutting drives will start.

MAYOR: Mayor Evans informed the BOW Jerry White suggested looking at rehabilitation of water lines in order to get a grant for rehabilitation of storage tanks. It would be an 80/20 grant. We will gather data on leaks in the past and have reports ready for the next round. KIRPC will administer the grant and will be paid through the grant funds.

Chief Brook McCain brought a recommendation for Colin Deckard to be promoted to Sargent. Anita Werling made the motion to approve the recommendation. Second by Mayor Evans. Motion carried. (2-0)

Board Resolution 2020-1: If we do not have this resolution for the plan passed, we would be unable to receive assistance. We would adopt the county's Multi-Hazard Mitigation Plan. Anita Werling made the motion to pass Board Resolution 2020-1. Second by Mayor Evans. Motion carried. (2-0)
