## **NEW BUSINESS:**

Mayor Evans brought a contract from Accu-Dig for work on the levee. This is required to be done every 5 years. The first part of the contract is for televising the levee pipelines with a cost of \$4,950.00. The second part is for the cleaning of the pipes with a cost of \$7,784.00. The total for both is \$12,735.00. Dick Bradshaw made the motion to approve the total of \$12,735.00 to Accu-Dig for levee work. Second by Anita Werling. Mayor Evans brought a purchase cost of \$6,040.00 for a hydraulic breaker with nail point for the water department. This equipment will also fit on the street department's bobcat. Water and street will split the cost. Mayor Evans made the motion to approve the purchase of the hydraulic breaker in the amount of \$6,040.00. Second by Anita Werling. Anita Werling, aye; Dick Bradshaw, aye; Mayor Evans, aye. Motion carried. (3-0)

Mayor Evans brought a purchase cost of \$8,084.00 for a 6'spiral slide for the parks department. The present slide is rusted and needs to be replaced. Dick Bradshaw made the motion to approve the purchase of the slide. Second by Anita Werling. Anita Werling, aye; Dick Bradshaw, aye; Mayor Evans, aye. Motion carried. (3-0)

Mayor Evans brought a request from the wastewater department to replace their existing mower. John Deere offered two quotes. The first quote was for a zero-turn mower with a 54" deck with a cost of

\$6,600.00 and the second was for a zero turn with a 48" deck with a cost of \$6,350. Dick Bradshaw made the motion to approve the purchase of the mower with a 48" deck and cost of \$6,350. Second by Anita Werling, aye; Dick Bradshaw, aye; Mayor Evans, aye. Motion carried. (3-0)

Mayor Evans asked for board comments:

Dick Bradshaw noted this was the first time for an electronic meeting and hoped this was not a permanent situation.
