## Common Council – March 4, 2024

Council was called to order at 6:00 pm on the second floor of the city building. Opened with the Pledge of Allegiance.

Roll call was given by clerk/treasurer-Julie Price. Members present: Kamron Yates, Erin Jubril, Spencer Kingery, Denny Myers, and Cody Nelson. Doyle Moore was absent.

The minutes from the February 5, 2024 council meeting were presented for approval. There were no additions, subtractions, deletions, or amendments to the minutes. Motion to accept the minutes was made by Cody Nelson, second by Erin Jubril, motion carried and passed. (4-0)

The council was presented with reports from the department heads. Without objection, the department head reports were incorporated by reference into the minutes. Without objection, other reports were suspended for the evening.

Resolution2024-5 Transfer of funds was presented for review by the council. Councilman Spencer Kingery asked if it was just an ordinary transfer of funds which was confirmed by Mayor Yates. Motion to accept resolution was made by Erin Jubril, second by Cody Nelson. Motion carried and passed. (4-0).

Resolution 2024-6 Reimbursement of expenditures was presented for review and acceptance. Council Myers asked what the reimbursement would be for and city attorney Miriam Robeson responded with the explanation of expenditures. Motion to reimburse the expenditures was made by Cody Nelson, second by Denny Myers. Motion carried and passed. (4-0).

Ordinance 2024-3 Read by title alone; establishing wages of certain employees was presented. Chief Lamar explained that proposed liaisons would work outside patrols, in schools, community events, etc. Extra patrols would be delegated and treated as specialty with a limit of 2. It would be an opportunity to get plugged in to the community. Cody Nelson commented that the increase of officer presence has had a positive effect on the community. A motion to suspend the rules of 2<sup>nd</sup> and 3<sup>rd</sup> reading was made by Spencer Kingery, second by Denny Myers. Motion carried and passed. (4-0) Motion to approve 2<sup>nd</sup> reading was made Erin Jubril, second by Cody Nelson. Motion was carried and passed. (4-0). Motion to approve 3<sup>rd</sup> and final reading was made by Spencer Kingery, second by Cody Nelson. Motion carried and passed. (4-0). Motion carried and passed. (4-0). Ordinance 2024-5 Read by title alone; Presented on first reading an ordinance amending Title VII, Chapter 77 of the City of Delphi Code of Ordinances Entitled "Utility Terrain Vehicles & Golf Carts and Exemption for the use of Utility Terrain Vehicles and Golf Carts by the Delphi Police Department. Exemption to include new city police golf cart for Police Department to use just as it is with police cars on duty. Councilman Denny Myers questioned how it would look to citizens and was assured by councilman Spencer Kingery that it would be used and operated in a professional capacity just as it would with city police vehicles on a routine basis. Motion to suspend second and third reading was made by Spencer Kingery, second by Cody Nelson. Motion carried and passed. (4-0) Motion to pass ordinance on second reading made by Spencer Kingery, second by Cody Nelson. Motion carried and passed. Presented on first reading is Ordinance 2024-6, Read by title alone. Proposed Ordinance 2024-6 Establishing Fund 4650 for the purpose of funding Construction of the new Water & Street Department building. City Attorney Miriam Roberson explained that the ordinance is for clarification when the new fund was created. Motion to suspend 2<sup>nd</sup> and 3<sup>rd</sup> reading made by Spencer Kingery, second by Denny Myers. Motion carried and passed. (4-0) Motion made to pass ordinance on second reading made by Spencer Kingery, Second by Denny Myers. Motion carried and passed. ## Miscellaneous Business:

Councilman Myers suggested possibility of getting microphones for council meetings so that the public would be able to better hear the council members and discussion of the meetings from the audience standpoint. Council member Erin Jubril stated a citizen commented about possibly taking down or replacing the worn out flags on Washington Street on the light poles or change them with the holidays or seasons to make the town more inviting. Citizen Shonda Isaacs stated that 1 light pole had the arm broken off possibly from a large semi or truck that may have passed through. Mayor Yates commented that he would have the street department look in to it. It was suggested that the Delphi Main Street may be willing to donate or purchase new flags for the poles.

## **Public Comment:**

Gayle Connor-Delphi commented about the 4650 fund. City Attorney Roberson responded that all questions ordinance was passed surrounding the fund and all information about the fund was shared. Any additional information would be shared as it was given to us. She also commented on the Solid waste contract and questioned why we could not use tax dollars or EDIT funds to help the public pay for the trash billing for citizens. She questioned the 2024 budget and appropriations and what the EDIT monies were used for.

Paula Duke-Riley Road asked why the council would vote to pass on the 2<sup>nd</sup> and 3<sup>rd</sup> readings instead of actually reading the 2<sup>nd</sup> and 3<sup>rd</sup> times to which councilman Cody Nelson responded that the rule was a self-imposed council rule so if the council chooses to vote to pass on the 2<sup>nd</sup> and 3<sup>rd</sup> readings, it has the option to do so. Carolyn Pearson stated that she feels it is important to have those 2<sup>nd</sup> and 3<sup>rd</sup> readings and stated that they never happened when she served on council. Gayle Conner stated that she felt the documents for public access should be posted earlier to give more time to the citizens to view them and was concerned that if they are not there in a timely manner, that citizens can't be informed ahead of

time to which Councilwoman Erin Jubril agreed that time, space, and transparency are all important aspects to consider for the public.

Adjournment

The motion to adjourn Common council was made by Erin Jubril and second by Cody Nelson. Motion carried (4-0) and meeting adjourned at 6:44 pm.

## Minutes March 25, 2024

## NEW BUSINESS:

The first order of business is proposed Resolution 2024-7 which is a resolution authorizing petition submission for the Delphi Tri-Township Fire Territory. Mayor Yates asked for a brief overview of the resolution to which Marcia Jura responded that it is authorizing the submittal of a petition to the state of Indiana DLGF to increase the maximum property tax levy for fire protection. It is solely based on census calculations and is being done by C.L. Coonrod &Co. who will be doing all of the paperwork and submitting it on behalf of the fire territory. The Fire Dept. could see up to \$15,000 gain to add to their general funds to aid in paying for fire equipment and expenses for items needed. Council Myers asked if they would just be getting a larger sum of funds to which Mayor Yates responded the funds gained from the resolution would go to the general fund. Justin Darling responded by thanking the council and stating that this is needing due to our growing population and the understanding the increase in the community and economic development.

Motion to pass Resolution 2024-7 was made by Spencer Kingery. Second by Erin Jubril. Motion carried and passed. (4-0)

## Adjournment

The motion to adjourn Common council was made by Spencer Kingery. Second by Denny Myers. Without objection, the meeting was adjourned at <u>5:13</u> p.m.


Officers are still being offered overtime to work school zone traffic enforcement.



## **Description of Services**

#### **Unlimited On-Site and Remote Support**

Brand Tech, Inc. will provide maintenance and support for the existing hardware and software including all equipment listed in the Addendum as well as installed 3rd party software and line of business applications. Brand Tech will provide support and troubleshooting for remote access solutions including VPN access, remote desktop and webmail including remote access setup of off-site computers. Brand Tech will make a best effort to resolve as many issues as possible remotely and will come On-Site in the event remote resolution is not possible. Remote support of other staff home computers is NOT included for access to the network. Projects outside the scope of the above to maintain the existing network are billed separately including but not limited to setting up 2nd or additional offices or system changes expanding beyond what is currently in use in the network are beyond the scope of this Agreement. Charges will be billed separately at Brand Tech's then hourly rate for service, currently \$125\_\_\_\_.

#### **Unlimited Automated Support**

Through the use of Brand Tech's Remote, Monitoring and Management (RMM) software, unlimited support by these systems will be provided. This includes the installation of critical updates for Windows Operating Systems, and Apple Operating Systems. Automated support includes remediation for installed malware, failed services, drive clean-up (temp and unnecessary files), drive optimization, virus, malware and spyware scans, defrags as well as hardware and software auditing. Brand Tech's remote monitoring and management software will monitor all PC's that are powered on 24/7 for critical errors. Critical errors will automatically create a Service Ticket in Brand Tech's ticket management system to be addressed by a technician or Brand Tech's automation Server which provides automatic response to resolve critical issues. Errors that occur during the maintenance window such as viruses found or machines that are unavailable will trigger a Service Ticket to be automatically created in Brand Tech's ticket management system.

All time billed by Brand Tech's Automated Support software will be covered under the terms of this agreement.

#### **Endpoint Protection / Antivirus**

All antivirus licensing is included for Servers, MAC's and PC's. Antivirus software is business grade antivirus (Sophos). Brand Tech monitors the antivirus software 24/7 and in the event of a virus/worm/ad-ware/spyware being detected a ticket will automatically be created in Brand Tech's ticket management system. Brand Tech will address viruses as requiring an emergency response by a technician to confirm virus removal.

#### **Security Threat Detection and Remediation**

Brand Tech provides managed threat detection and remediation services to uncover and address malicious network penetration attempts.



#### Security Awareness Training

BRAND TECH includes security awareness training if requested. Training may include simulated phishing attacks, instruction in company IT policies and best practices, compliance training and testing.

#### Virtual CIO

BRAND TECH provides quarterly meetings with City of Delphi to review ongoing issues, go over upcoming project work, discuss changes in vendors, advise on best practices, create budgets and plan the technology roadmap for the next period.

City of Delphi agrees that weather, traffic conditions or Force Majeure outside the control of Brand Tech may extend or prevent remote or onsite response.

## **Managed Services Requirements**

- PC's, Servers and network equipment including routers, switches, backup devices and media must be less than 5 years old or turning 5 years old in the first 11 months of the agreement. Servers must be replaced by City of Delphi upon reaching the age of 5 years. Replacement installation costs are billed outside the monthly service amount at BRAND TECH's then hourly rate. Servers must be covered by an active hardware warranty. BRAND TECH will coordinate warranty diagnostics, repairs and return to service.
- 2. PC's (laptops/desktops/Macs) in excess of 5 years in age that fail will need to be replaced by the City of Delphi with a new machine or one that is less than 5 years in age.
- 3. All Servers, Desktop PC's and Notebooks/Laptops with Microsoft Windows or Apple operating systems must be running an operating system supported by Microsoft or Apple with support expected to continue 12 months or more with the latest service packs and critical updates installed. As Microsoft or Apple stops supporting an operating system City of Delphi must update their operating system or remove it from any access to the network.
- 4. City of Delphi will maintain service/support contracts for hardware such as routers, firewalls and switches and specialty software applications.
- 5. If a City of Delphi has software particular to its business which is installed on its network, the City of Delphi is responsible to obtain installation, training and continuing technical support from the software provider. Brand Tech technicians are able to assist with network support but they are not experts in all software applications and rely on the software manufacturer to provide software support at City of Delphi's expense.
- 6. This Agreement covers users and their associated computers and other devices as detailed in the appendix. If City of Delphi has a Desktop or Laptop that is critical to never be down, it is recommended that City of Delphi keep a spare similar device on hand as Brand Tech is not responsible for extended downtime in case of failure of device.
- 7. For each new user added during the term of this agreement beyond computer/users the monthly Managed Service fee will increase by \$30 per month.
- 8. All server and desktop software must be genuine, licensed and vendor-supported.
- 9. The network must have a currently licensed, vendor-supported server-based backup solution that can be monitored and send notifications on job failures and successes.



- 10. The network must have a currently licensed, vendor-supported hardware firewall between the internal network and the Internet.
- 11. All wireless data traffic in the environment must be securely encrypted.

At the time of initiating service for City of Delphi, Brand Tech will evaluate City of Delphi's network and determine whether all Managed Services Requirements are in place and if not in place will install the required services. Charges for bringing the network into compliance with the requirements will be billed as incurred as additional services.



## Agreement

City of Delphi and Brand Tech agree to the following:

- Brand Tech will provide the Managed Services listed on the Managed Services Offerings. The term of this Agreement is 12 months beginning \_11/1/2023\_. This Agreement will automatically renew for successive 12-month terms unless at least 30 days prior to the expiration of each such term, either party notifies the other party in writing of non-renewal. BRAND TECH or City of Delphi may terminate this contract at any time, after an initial 12-month period with at least 30 days prior written notice. Service to be provided to City of Delphi is for the network located at the address set forth in the attached Description of Network Equipment Supported for the equipment described therein.
- City of Delphi agrees to all requirements in the preceding pages of this document.
- City of Delphi will pay BRAND TECH monthly on or before the 1st day of each month the amount of <u>\$ 2205</u>.; BRAND TECH does not have a site visit charge. If the City of Delphi is in a jurisdiction which charges sales tax on services the stated price does not include tax.
- BRAND TECH's hourly rate for additional services for Projects out of scope is \$125.
- This Agreement covers only the City of Delphi's locations as referenced in the addendum and its IT assets, services, service hours, and covered days defined within this Agreement.
- The addition of locations, IT assets, services, service hours, and covered days not set out in this Agreement will require billing as additional services or a project or result in an adjustment to the City of Delphi's monthly charges. For example, City of Delphi moving to a new location or adding additional users requiring additional routers and networks are Projects. All services requested by City of Delphi which are not included in the coverages set out in this Agreement are billed as "Additional Services" or a "Project" and will be quoted and billed as Separate Charges at BRAND TECH's then hourly rate plus expenses. Expenses may include but are not limited to travel, parking, and tolls.
- BRAND TECH will begin and maintain network documentation: on-going documentation of hardware, software, network settings, IP addresses, firewall settings and related network information.
- BRAND TECH will make available to City of Delphi discounted pricing on servers, laptops, desktops and network equipment.
- City of Delphi will comply with the Policies and Responsibilities and also the Managed Services Requirements.

Confidentiality During the term of this Agreement, and thereafter in perpetuity, neither party shall without the prior written consent of the other, disclose to anyone any Confidential Information of the other. "Confidential Information" for the purposes of this Agreement shall include each party's proprietary and confidential information such as, but not limited to, customer lists, business plans, marketing plans, financial information, designs, drawing, specifications, models, software, source codes, and object codes. Confidential Information shall not include any information that City of Delphi makes publicly available or information which becomes publicly available through no act of BRAND TECH or City of Delphi or is rightfully received by either party from a third party.
- City of Delphi and BRAND TECH both agree that they will not solicit for hire and it will not hire or otherwise engage any of each other's employees or contractors, either directly or indirectly during any period services are provided under this agreement or in the 24-month period immediately following termination of this agreement.

Force Majeure: Neither party shall be liable for any failure of or delay in performance of its obligations under this Agreement to the extent such failure or delay is due to circumstances beyond its reasonable control, including, without limitation, acts of God, acts of a public enemy, pandemics, fires, floods, wars, civil disturbances, sabotage, accidents, insurrections, terrorism, blockades, embargoes, storms, explosions, labor disputes (whether or not the employees' demands are reasonable and within the party's power to satisfy), acts of any governmental body, failure or delay of third parties or governmental bodies from whom approvals, authorizations, licenses, franchises or permits must be obtained, or inability to obtain labor, materials, equipment, or transportation or illness of BRAND TECH's technical staff (collectively referred to herein as "Force Majeure"). Each party shall use reasonable efforts to minimize the duration and consequences of any failure of or delay in performance resulting from a Force Majeure event.
- 4. If the City of Delphi work is substantially changed due to a Force Majeure, BRAND TECH will evaluate the need for change to IT services to City of Delphi and related change of managed service fees. Recognizing there are ongoing expenses to BRAND TECH of maintaining backups, remote monitoring, other vendor support software/licensing and availability of technicians to service on going needs, BRAND TECH will review with City of Delphi the need for change of fees if any.
- 5. BRAND TECH shall not be liable to City of Delphi or any of its affiliates for any damages, whether incidental, direct, indirect, special, consequential or punitive damages arising out of service or equipment provided hereunder, including but not limited to loss of profits or revenue, loss of use of equipment, lost data, or loss to person or property, costs of substitute equipment or other costs even if BRAND TECH has been advised of the possibility of such damages. Regardless of the form of action, BRAND TECH's cumulative liability shall be only for loss or damage directly attributable to negligence of a BRAND TECH employee or contractor, for the cost of restoring the network to its condition prior to the negligence, but not to exceed thirty thousand Dollars. If a



collection action is initiated by either party or if BRAND TECH has to defend any action by City of Delphi, BRAND TECH is entitled to its reasonable attorney fees and expenses to be paid by City of Delphi.

- 6. Implied Warranties are expressly disclaimed by BRAND TECH. An BRAND TECH contractor is a technician or contractor who operates on behalf of BRAND TECH, is paid by BRAND TECH and has access to BRAND TECH's service ticket management system for making time entries and charges for their work. BRAND TECH is not responsible for the acts of other technicians, contractors or consultants providing service to City of Delphi not under its control and direction. If City of Delphi purchases equipment from BRAND TECH it understands and agrees that it will look to the manufacturer for all remedies and warranties and agrees that BRAND TECH is not responsible for functioning of the equipment and has not made any express or implied warranties. BRAND TECH shall not be liable for any claim or demand against the City of Delphi by any third party on account of errors or omissions performed hereunder.
- 7. Remote access to personal computers and/or networks. If or when City of Delphi transitions to home or alternative networks, BRAND TECH will make best effort to make connections and serviceability. However, home or alternative networks may not have adequate internet connectivity and equipment to effectively work. BRAND TECH is not responsible for inadequacies in those home or alternative networks or to secure those connections. Home equipment will not be as secure and may not have BRAND TECH's software and security features. BRAND TECH is not responsible for the security of the home or alternative networks. Work on a home or alternative network unless otherwise included is outside the scope of this Agreement and BRAND TECH may charge it's then hourly rate for work on home or alternative networks. BRAND TECH will charge for additional software installed at home or alternative networks as needed.
- 8. In the event of a Force Majeure BRAND TECH is not required to have technicians work during periods or at places where their safety or health could be in jeopardy and in any event will not require technicians to go on site.
- 9. City of Delphi agrees to carry liability insurance and property insurance covering any damage to its network as well as any City of Delphi adversely affected by City of Delphi's network functioning or transmissions from its network.
- 10. BRAND TECH may apply changes or additional terms, conditions and provisions to this Agreement upon 30 days advance written notice to City of Delphi containing the proposed addition or change. If the additions or changes are not objected to then they shall take effect at the end of the 30 days. Within the 30 days City of Delphi may submit changes or objections to the proposed changes or additional terms. If the parties do not agree on the change or addition then it shall not become part of the Agreement. All the terms, conditions and provisions of this Agreement will continue to apply during any renewal term. Both parties agree to negotiate in good faith rates to be mutually agreed under any renewed contractual service term to be effective at the end of the initial term.



- 11. Failure to pay: If payment is not received by the first of the month for that month of service BRAND TECH reserves the right to put a hold on rendering on-site and remote services until monthly fee has been paid, provided BRAND TECH gives a five (5) business day notice of late payment.
- 12. It is understood that any Federal, State or Local Taxes applicable shall be added to each invoice for services or materials provided by BRAND TECH. City of Delphi shall pay any such taxes unless a valid exemption certificate is furnished to BRAND TECH for the jurisdiction of use, except in cases when BRAND TECH procures or sources the incorrect equipment and / or software and / or support services any incorrect items or software shall be returned to BRAND TECH.
- 13. If City of Delphi fails to make payment for any services or items purchased, and such failure continues for fifteen days, interest shall accrue on any amount due at the rate of 12% per annum until paid. In the event collection processes are instituted to collect any amounts due from City of Delphi, City of Delphi shall pay the costs of collection plus reasonable attorney fees.
- 14. This Agreement is fully assignable by BRAND TECH. Immediately upon assignment the assignee's name, address and contact information shall be provided to the other party. This Agreement shall be fully binding and enforceable as against all permitted assignees and successors in interest.
- 15. Termination: Termination by City of Delphi: City of Delphi may terminate this Agreement with or without cause after the first 12 months of the Agreement have passed payment of a Termination Fee equal to the amount of the monthly Managed Services fee agreed to in this Agreement \$1000 and ii.) payment of all past and currently due amounts together with late fees and costs unless City of Delphi has valid reason to withhold payment on incomplete tasks, work orders or faulty equipment and provided BRAND TECH was notified in a service ticket within 10 days of the original occurrence of any incomplete tasks, work orders and/or faulty equipment which it itemized with sufficient detail to identify the problem. That amount may be withheld until the incomplete tasks, work orders or equipment issues are resolved. BRAND TECH shall be given a reasonable opportunity to correct any problems. Any such election shall be made in writing by Notice of Termination and is to be accompanied by the Termination Fee and all other amounts due.

Termination by BRAND TECH:

a. Upon giving notice to City of Delphi of default and the default is not cured within ten (10) business days of receipt of written notice from BRAND TECH or for failure of City of Delphi to pay for service or products at the time of ordering or within 30 days of billing. Failure of BRAND TECH to require payment at the time provided shall not be construed as a waiver of the right to do so.



- b. Any of the following which remains un-dismissed for a period of sixty (60) days: If City of Delphi files protection under the federal bankruptcy laws, or any bankruptcy petition or petition for receiver is commenced by a third party against City of Delphi.
- c. Failure of City of Delphi to comply with its obligations in this Agreement after written notice by BRAND TECH of the non-compliance and failure to correct the problem or acknowledge the problem and commitment to take corrective action in the future.
- d. Backups in the event of default or early termination or in the event the parties do not renew at the end of the term of this Agreement: City of Delphi shall be responsible for transferring backups to a system administered by City of Delphi or others on its behalf and for paying any costs of transferring and/or setting up backups off of the system maintained by BRAND TECH. If City of Delphi does not provide for any transfer of backups, they shall be terminated within 30 days of the Notice of Termination or Notice of Default. City of Delphi assumes all responsibility for its backups and BRAND TECH has no responsibility to retain backups. In the event prior to the end of the 30 days, City of Delphi places its own backups on site or obtains its own cloud backups then it shall notify BRAND TECH so it's backups can be terminated.
- e. In the event of default or termination under any circumstances City of Delphi agrees it will provide access to BRAND TECH technicians to remove antivirus licenses and monitoring tools. The consequence of and failure to provide this access shall be that City of Delphi shall continue to be responsible for 50% of the amount of the monthly Managed Services payment until access is allowed and the licenses and tools removed. Spam filtering will be terminated upon default or termination. City of Delphi understands that it is entirely responsible to redirect all of City of Delphi's MX records away from the spam filter system and redirect email to its server or it must provide BRAND TECH access to its network information and equipment to take those steps. Upon termination of spam filtering services email will bounce if City of Delphi understands the above and accepts this responsibility and the consequences if it fails to cooperate or act; City of Delphi acknowledges that upon termination of the spam filtering if these steps are not allowed or taken email will not be available and there is no recourse whatsoever to BRAND TECH.
- f. In the event of termination by either party, City of Delphi is responsible for the full amount of all payments for services provided and products ordered.
- g. If either party terminates the relationship of managed service provider and City of Delphi or if City of Delphi defaults then the parties agree to work cooperatively to transfer the City of Delphi's data and network information as directed by the City of Delphi to another service provider or to the City of Delphi. The City of Delphi will pay the cost of transfer which will include hourly charges of technicians to accomplish the transfer and any services maintained by BRAND TECH containing City of Delphi data. City of Delphi must designate a vendor to handle its email, backups and any other services provided by BRAND TECH. City of Delphi must establish an account for transfer of the backups and any other services within 30 days of notice of termination or default, or within 30 days of termination of this SLA. BRAND TECH



has no responsibility for backups, email or other services beyond 30 days following termination or default under this Agreement.

- h. In the event of termination of services for any reason by either party, upon written request by City of Delphi BRAND TECH will provide up to 60 days support to allow City of Delphi to make a transition provided City of Delphi pays all amounts then due and pays the fee for the additional 60 days in advance.
- 16. Dispute Resolution: All claims and disputes arising under or relating to this Agreement are to be settled by binding arbitration unless they are of an amount which can be handled within the small claims court of the jurisdiction of the BRAND TECH. The parties agree they waive the right to bring a lawsuit based on such claims or disputes other than in small claims court. Before commencing any arbitration proceedings the aggrieved party must first present the claim or dispute in writing to the other party. The parties shall have 30 days to resolve the claim or dispute. If not resolved then the aggrieved party may commence arbitration proceedings. The arbitration shall be conducted by Arbitration Resolution Services, Inc. (ARS) or other mutually agreed upon dispute resolution service and the parties shall be bound by any and all rules of the American Arbitration Associations United States Commercial Resolution Dispute Resolution Procedures for Consumer-Related Disputes. Any decision or award as a result of any such arbitration proceeding shall be in writing and shall provide an explanation for all decisions. Arbitration shall be conducted by an arbitrator experienced in Information Technology services and experience required for arbitrator and shall include a written record of the arbitration hearing. An award of arbitration may be converted to judgment in a Court of competent jurisdiction. The location of arbitration shall be in the home city, county of BRAND TECH. The fees and expenses of the arbitrator and proceedings shall be paid by the losing party.
- 17. This Agreement and any amendments and its validity, construction and performance shall be governed by the laws of \_Tippecanoe County, Indiana. Exclusive jurisdiction and venue for all matters relating to this Agreement shall be in the county and state of the BRAND TECH, and the parties agree and consent to such jurisdiction and venue.
- 18. This Agreement does not create any rights in any third parties.
