Dick Bradshaw stated he would like to hear from the guests. Deb Lowe questioned why we were not talking about water and the cost. Dick Bradshaw noted that was usually done at their work sessions. The first priority has been the connection of well 3 to 5. Mayor Evans stated we are currently working on our priorities. There is lots that needs to be addressed before numbers can be determined. Cooperation with IPC and US Ag will be part of the final numbers. Mayor Evans noted the decline in the water table and stated IPC can't ask for more than we have.
